## 2. BUSINESS ARISING FROM THE PREVIOUS MEETING

## 4. GENERAL BUSINESS

- The President, Christine Lock, informed the meeting that 2 new First Aid Boxes

have been bought – one for the Perth area and one for the Albany area.

2. Noel Clarke brought to the attention of the meeting and the committee three constitutional matters, which will be considered by the committee. The 3 points related to:
    - a. The Registrar and Conservation Officer positions are not formally covered by the Office Bearers as listed in Clause 3 of the Constitution. Should these positions be formalised and included Clause 3?
    - b. The management of the affairs of the Group is vested in the Management Committee, as per Clause 15. Other non-Management Committee members may attend the Committee meeting – consideration should be given to allowing general members to also attend Committee meetings as observers.
    - c. Proper process, according to Clause 10, was not observed when Gloria Jackson was made an honorary member. Noel Clarke made the further point that a dangerous precedent may have been set by the Group paying for 2 people to attend the DEC Conservation Awards dinner, and for a member to attend a conservation seminar. A written submission relating to these points was handed to the Secretary, which will be considered by the Committee at the next available meeting.
  3. The Conservation Officer, Eddy Wajon, read and discussed the Conservation Report
  4. Donna Wajon informed the meeting that orders for Group shirts and jackets will be taken, with payments, at the next meeting in April 21<sup>st</sup>.
  5. Noel Clarke informed the meeting that the commercial TV area in Dianella is to be vacated, and a local group is trying to get the area set aside for conservation.
  6. The President discussed the fact that the Group is intending to become more involved in research topics, and will be looking for volunteers to participate in the activities.

### ERIC SWARTS – our new Vice-President



## **CONSERVATION ISSUES**

### **CONSERVATION REPORT – 7 FEB 2010**

#### Woodanilling

Letter written early January (no reply as yet)

- asking for agenda/schedule of activities to repair / remove stockpiles at Reserve
- asking for reason/status of Martup Pool clearing and piles of vegetation
- making comments on ongoing clearing of Robinson Rd

DEC investigation of suspected illegal clearing: emails sent asking for status have not been answered.

#### Toodyay

Wrote further letter to Minister of Environment complaining about overlooked requirement in cover letter to appeal on clearing permit for community consultation to occur and inadequate offsets (no reply as yet)

Shire of Toodyay has been required to undertake another spring survey at appropriate time for *Thelymitra stellata*

No clearing happening yet.

#### Jandakot

Decision delayed to early March to probably allow joint discussion and announcement on EPBC Act referral and Master Plan  
Protest held Dec 21<sup>st</sup>, 2009 received lots of encouragement from motorists

JAH proposed further activities/actions to Canning City Council which were on agenda at Council meeting but these were discussed in private. Eddy Wajon asked 6 questions prior to meeting about orchids to make sure Councillors remained aware of what was at stake. JAH proposal was defeated and Council re-affirmed opposition to JAH revegetation of open barren sand mines  
Eddy Wajon has had belated contact from Dennis Jensen's press secretary with respect to a workshop or consultation regarding siting commercial development on the open barren sand mines.

Reply received indicating planning has been occurring for some time and that a Strategy was presented to the relevant Minister (Sport and Recreation) in May 2008. Government established a committee to cost the recommendations but has yet to make a decision.

DEC is conducting its own study into the feasibility of a dedicated trail bike track through lands they manage.

## **BANDED GREENHOODS**

Over the years there has been much discussion/heated argument over 'which one is that' in reference to various banded greenhoods. The table that appears on the next page is an effort to provide a comparative guide.

I would like to thank Andrew Brown for his help with this guide. The guide has no column for plant height or leaf characteristics as Andrew suggests that these vary so much depending on conditions that they have limited value in distinguishing which species a particular plant might be.

For some of the flowers you will need an accurate ruler as part of the distinction is about size. However, as Andrew says, it is a matter of taking all the elements into consideration. With the great *vitatta/sanguinea* debate it is often location that is a key as well as time. Find a *vitatta* early and you will be right.

With the sp '*coastal*', the sp '*northern*' and the sp '*Dongara*' identification is quite tricky. They are probably/possibly forms of *sanguinea*, but each is consistent within the geographical areas in which they are found. This helps a bit, but they overlap somewhat, meaning that what you need to find is one that is as distinctive as possible. In the guide there are occasional words underlined and these are hopefully the key aspects.

While the specific locations for most are not given, there are a couple indicated and members are welcome to contact the editor about those two. What would be of great use would be photos and specific GPS locations for middle 6 species (ie not the first 2 or the last one). These can be sent to the editor and/or Christine Lock (President and also the Registrar, who is keeping the club's data base up to date)
