The website should NOT be aiming to encourage more new members, due to issues of trampling and digging up of orchids that already exist.

<u>SEXUAL DECEPTION IN ORCHIDS :</u> <u>Recent Research findings</u>


Guest speaker at the WANOSCG meeting on 20th April was Professor Rod Peakall, Evolutionary Biologist from ANU, Canberra and formerly a UWA Botany graduate.

He stated it was good to be "home" in WA again and gave us a very interesting presentation called "The False Promise of Sex: how orchids use chemicals to lure insects."

He told us that approximately one third of orchid species use deception to attract their pollinators. While most of these orchids are food deceptive (looking and smelling like flowers that offer nectar or pollen as food), some deceptive orchids lure their specific pollinators by sexual deception. Sexually deceptive orchids lure male insects by mimicking a female insect. This process is the most well-developed in Australia and commonly involves Thynnine wasp species. Certain orchids have developed floral odours that mimic the sex pheromones of the female wasp and this appears to be the most significant attractant for the male pollinators. Secondary attractants are visual and tactile mimicry of the female wasp form as part of or all of the labellum, e.g. Drakaea.

In studies of Australian sexually deceptive orchid floral odours, his team has found that among hundreds of compounds, there are only a few that are the active attractants for the pollinators.


Initial studies on Chiloglottis species in the Eastern states discovered that only one or two compounds are involved in both the wasp pheromones and the orchid's mimicry of the pheromone. These compounds were entirely new to science and have since been named "Chiloglottones".



Chiloglottis and Drakaea are sister species that have evolved separately from a common ancestor. It was therefore predicted that Drakaea would use similar compounds.

Surprisingly, however, this was not the case! Ongoing research has found that the Drakaea pollinators respond to up to 7 compounds. Furthermore, these compounds are of a different chemical composition to those of Chiloglottis. The Drakaea attractant compounds are called Pyrazines. While these kinds of compounds are known from other plants and insects, many of the Pyrazines found in Drakaea are new to nature. Given the larger number of compounds involved, the unravelling of the attractant pheromone puzzle in Drakaea will be a much more complex task than that of Chiloglottis.

The amazing thing is that the orchids have evolved and specialised to such an extent that they are able to intercept the complex communication channels between the male and female wasps in order to achieve a high degree of pollination and ensure survival.



The fact that most Drakaea species attract only one species of wasp highlights their vulnerability and dependence on many external factors for their continuing survival.

This was a very interesting presentation and gave us an insight into both the complexity of the current research projects and the amazing evolution of the orchids.

CHANGE TO PUBLICATION OF NUTYTSIA: **BULLETIN OF WESTERN AUSTRALIAN HERBARIUM**

Published in "Western Wildlife" Vol 15 No. 2, April 2011

The Western Australian Herbarium was established in 1928, and its officers started to collect specimens and record information about WA's plant species and communities. At first there were very few staff, and as information accumulated, research papers were published in a wide range of both local and overseas journals. To bring all this local taxonomic research together, a new journal, Nuytsia, was launched in 1970.

At this time the WA Herbarium was part of the Department of Agriculture and on its transfer to the Department of Conservation and Land Management (now DEC) in 1988, publication continued unabated. But changes were looming. It was becoming more and more expensive to produce each issue and in addition, the electronic communications revolution meant that people began to search for material online, rather than on a bookshelf. So, Nuytsia volume 20, published in November 2010, will be the last to be distributed as a paper copy.

From 2011 on, Nuytsia will be published online only, except for a few hard copies necessary to comply with the international requirements for formal publications of taxonomic names. The online version is freely available for download.

White Bunny orchids flowering as usual. Not much else to report.

Although, a nice last spring burn in and around Boronia Estate subdivision off Karri Rd, Walpole looks promising to us for spring this year.

Another big burn (controlled) was done at William Bay from Elephant Rocks and west from there.

The next one planned imminently is west of William Bay towards Parry Beach. Even these late burns can stimulate extra orchids in the late spring, early summer down here if the rain is adequate.




There was also a late spring burn along the Denmark/Mt Barker rd stretching 11km south of the south side of Blue Lake rd.

It's our experience that these burns yield the most orchids late in the year down here – but in saying that, we were out there a few days ago looking at attractive leafless orchids.

On the weekend 30th April / 1st May we decided to look for bunny orchids at Wave Rock near Hyden. On the way granite outcrops on Brookton Hwy were very disappointing. The terrain between Brookton, Corrigin and Hyden was the driest we have seen in years. The bush around Wave Rock looked really scorched and black in colour. Though, to our surprise, just where the vegetation meets the granite little signs of life were evident. We spotted 16 crinkle-leaf bunny orchids. 7 flowering and the rest with one or two buds. Unfortunately we saw not only orchids but many more cigarette butts around the plants.
