ACC ORCHID CONSERVATION POLICY

The Australian Orchid Council wrote to WANOSCG earlier this year regarding the development of an orchid conservation policy. The following summaries of the letter and attached reports are included for member's information and comments.

AOC has agreed to fund an interstate telephone link up of State Coordinators, in June/July to help develop a conservation policy. Prior to this Coordinators need to have firm ideas on what their requirements are from grower and conservation groups within the State. Reports produced by ANOS groups and the WANOSCG are included, and may be used as a starting point for policy formation. The inaugural Australian Native Orchid Conference will be held this September and it is hoped AOC will have a draft policy for presentation and comment.

INTERIM REPORT OF THE CONSERVATION SUB-COMMITTEE OF ANOS

Some important steps that can be taken by each affiliated Society of A.N.O.S. include:

- 1. The establishment of a TUBER BANK by those societies that at this moment do not have one operating. Tuber banks should be organised at two levels.

 Firstly the aim of a tuber bank should be to supply tubers of terrestrial orchids to meet the internal demands of growers within that particular society.

 Secondly, a long term aim of tuber banks should be to provide tubers to meet external demands around Australia. If such tuber banks were established throughout the states of Australia, pressure on wild populations of orchid species would be greatly reduced. The Conservation Sub-Committee of A.N.O.S. will be supplying information as to how to establish and organise tuber banks within societies.
- 2. A Conservation Officer needs to be elected by each A.N.O.S. affiliated society to monitor conservation activities within their own society or area. Each officer would act as a contact with the Conservation Sub-Committee of A.N.O.S.
- 3. All affiliated societies need to monitor the behaviour of their members in matters of conservation and to also monitor the plants brought into monthly meetings.
- 4. Members of societies need to be involved in "hands on" approach to conservation in matters such as rescue digs and relocation of plants to "safer" areas.
- 5. All affiliated A.N.O.S. societies should be encouraged to become more self-reliant in matters of conservation within their own state or local area.
- 6. Discretion should be used by societies and their members concerning information about the location of rare and endangered species of orchids.
- 7. People with access to rare and endangered species should be encouraged to make seed of those plants available to those with the ability and resources to use the seed for conservation purposes.
- 8. To encourage people with expertise to make their abilities available for the purposes of conservation.
- 9. The establishment of a SPECIES BREEDING PROGRAM to mass produce seedlings that can be made available to members and other affiliated societies.
- 10. All affiliated A.N.O.S. societies should inform other societies of their actions and achievements regarding conservation.
- 11. Societies should encourage and foster members interested in researching improved methods of growing and multiplying our native orchid species.

- 12. Societies should compile a list of the orchid species of their state or area, that are most critically endangered through exploitation and changes in land usage. Local bodies should be informed of the seriousness of the situation.
- 13. We should work towards having more native orchids placed on the Protected Flora Lists.
- 14. Make accurate slide programmes available for use by A.N.O.S. affiliated societies, showing the species available from the particular group, so as to motivate and encourage interchange of tubers and seedlings.
- 15. Constantly improve the education of our members in matters regarding native orchid species, which should lead to an increase in the desire to conserve those precious botanical resources still left in Australia.
- 16. Affiliated societies with problems or suggestions in matters of conservation should contact the CONSERVATION SUB-COMMITTEE regarding these matters.

ANOS CONSERVATION SUB-COMMITTEE ANNUAL REPORT 1989

ANOS developed a conservation policy which was adopted at last year's AGM. The Conservation Sub-Committee has endeavoured to keep in contact with all ANOS groups and associated societies through a Conservation Newsletter. It has created a Conservation Fund which will be used to promote conservation. To help raise funds the first of the annual conservation badges was released and was well received.

<u>Diuris purdiei</u> from WA was the subject of the first badge. It is also proposed to run NSW tuber bank to increase the availability of terrestrial orchids from legitimate sources and raise funds for the conservation fund.


The Sub-committee has over the year written to the NSW and WA governments conserning <u>Diuris purdiei</u> and <u>Pterostylis gibbosa</u>.

This year's conference has a conservation emphasis and we are working towards making it a vehicle for increasing public awareness and support. The Sunday is being devoted to the issue of conservation and hopefully from this will come the guidelines which will give this Sub-committee its future direction.

The most pleasing aspect of this year has been the significant increase in the involvement of individual societies in conservation matters. Almost all societies now have conservation officers while some have even their own committees and group meetings.
